Sealed quotations are invited from firms of good repute who are registered with PEC in C-A & C-B category in relevant field of specialization and Income Tax Department for carrying out **Construction of Water Works Package-III** at Pakistan Textile City at Eastern Industrial Zone, Port Qasim, Karachi.

The main components of Water Works shall be as follows:

- 20 MG Capacity RCC Covered Underground Tank (Civil & Mech. Works)
- Raw Water Pump House (Civil, Mechanical & Electrical Works)
- Fire Water Underground Tank & Pump Room (Civil, Mech, & Elect, Works)
- 1.5 MG Potable Water Underground RCC tank and Pump Room (Civil, Elect, & Mech. & Works)
- Filtration & Chlorination Units (Civil, Mech & Elect. Works)
- RCC Overhead Tower for Potable Water (Civil, Mech, & Elect, Works)
- Boundary wall, Internal Roads, Area Electrification, Allied Buildings, etc.

TERMS AND CONDITIONS

'Technical Bid' and 'Financial Bid' are to be submitted separately in two sealed envelopes marked accordingly. Information to be submitted for technical bid will be provided with tender documents,

The bids must be submitted to Pakistan Textile City Limited's Head Office by 1600 hours on **July 10, 2009**. The Technical Bids will be evaluated in accordance with the specified evaluation criteria. The Financial Bids will be opened in presence of technically qualified bidders soon after the completion of technical evaluations. Date & time will be announced later.

Incorrect, false or misleading information submitted as part of 'Technical Details' will result in disqualification of the proposal. If discovered during execution of a contract as a result of a bid, it may result in termination of the contract, confiscation of security deposit and necessary legal action for recovery of associated financial/material losses.

The competent authority reserves the right to accept or reject any or all bids without assigning any reason and without any liability whatsoever.

Conditional bids will not be accepted.
